

Message from Our Executive Director



Dickinson Area Chamber of Commerce 108th Annual Banquet Speech Recap

Working in this position has been the most fun I've ever had professionally, and that is due in very large part to the direction and tone the Board of Directors has set for my 2-1/2 years here. Since I've been here, every single one of

the Board members I've had the pleasure to work with has been knowledgeable about the community, committed to the Chamber's mission, and respectful of each other and the Chamber's staff and volunteers—because of this the Chamber has been able to do some pretty awesome things. Christian now takes the helm as the latest in a long line of great Board Presidents. I have no doubt he will do a wonderful job and I'm grateful for his willingness to serve.

I'd like to start, as I do every year, by reiterating the mission of the Chamber, which is "to provide leadership to promote a progressive business environment." This is why we do everything we do. Every event we undertake, every activity we participate in, every endeavor we sponsor, every meeting we attend, every marketing piece we create—all of these things are matched against this mission statement to make sure that they help to accomplish it. The chamber is the place for businesses, clients, volunteers and industry professionals to connect and work together towards the common goals of strong economy and quality of life. We are more than 550 members strong. And we recognize that together, we can do far more than any of us can do alone.

The chamber has been around since 1906—first as the Dickinson Commercial Club, then in 1924 as the Dickinson Association of Business and Public Affairs. In 1945 it was officially incorporated as the nonprofit organization we know now, and began accepting memberships.

The amount of growth we've seen at the Chamber in the past few years has absolutely mirrored the growth throughout the community. In the past 4 years, we've seen about $1/3^{rd}$ of those 550 members join. Members are more diverse than ever before—and only becoming more so representing just about every sector of business and almost every one of the United States.

Business leaders join the Chamber for various reasons. In 1908, President Theodore Roosevelt said: "Every man owes part of his time and money to the business or industry to which he is engaged. No man has a moral right to withhold his support from an organization that is striving to improve conditions within his sphere." Some businesses or organizations join the chamber in this spirit—because it's the right thing to do, or because they have something to offer or "give back." Others see it as a worthwhile investment in the community, whose Return on Investment is unmatched. Others join because of the countless advertising, promotional or sponsorship opportunities we have, or information we offer, or events we organize, or networking chances we provide, or simply to have the chamber logo on the front window. Whatever your reason for joining the chamber, we work every day to earn that membership.

In an effort to earn that membership and support this community, the Chamber has participated in various new endeavors this year.

 We helped create and continue to support the Downtown Dickinson Association, recognizing that a healthy downtown is an absolutely integral part of a thriving community, and is a benefit to all whether located in the downtown or not.

- We created the first ever State of the City event, and had representatives from DSU, St. Joseph's Hospital, Dickinson Public Schools and the City of Dickinson give a state of community affairs from their organization's perspective—and we even fed you lunch while you listened!
- Seeing a need in our community for more professional development opportunities, we partnered with DSU's Strom Center for Entrepreneurship and Innovation to provide monthly Lunch & Learns on topics ranging from social media to employee retention and just about everything in between.
- The last major program change I wanted to mention was the Chamber's public support of the Dickinson Public Schools Bond Issue. Just last month marked the first time in its 108-year history that the Chamber has vocalized its unified support publicly for a particular political issue—and it was certainly nice to have initiated the endeavor with a victory. This represents a massive shift in policy for the Chamber, and took years to implement. This shift towards political action is a difficult one, and a very delicate one. We promise to remain responsible, measured and deliberate in what efforts we support or oppose. But we will fight for you.

The most amazing part, to me, is that all of these new directions, activities and endeavors happened not at the expense of existing programs, but in addition to them—with relatively similar budget numbers, and the same number of staff (and for much of the year, less staff).

This is a testament to nothing other than our *absolutely superb* volunteers. You all step up incredibly in this area, and I couldn't be more grateful for it. The chamber has over 100 volunteers from our member businesses, serving on 7 different committees. These committees include Agriculture, Ambassadors, Education, Governmental Affairs, Leadership, Recreation, and Promotions. Their activities have included planning, executing and cleaning up after events, shaking hands and waving hands from a parade float, setting up tables, chairs and signs, serving chili, making lunch and eating donuts, delivering balloons and cards and even, as I was reminded this weekend at the West River Livestock Show, following cows around with a shovel. Why do you do this? Because you love your community. And if you are not involved with a committee, I encourage you to contact me immediately—I guarantee that whatever committee you join will be better because of your presence.

Friends, colleagues, volunteers, and Chamber members. We live in a truly momentous time in the history of the Chamber, of Dickinson, and of the State of North Dakota. Thanks to you, we stand poised as a chamber and as a community to meet head on the challenges we face with confidence, clear vision and optimism. I invite us all to recognize the amazing opportunities in front of us in this blessed community, and rededicate ourselves in the coming year to the accomplishment of our unified goals and vision.

But for now, all I really want to say is thank you. On behalf of my family, the Chamber Board of Directors and Chamber staff, thank you. Thank you for your service. Thank you everything you do. And thank you for coming tonight. Have a wonderful evening, and drive safely.

When the exact date to move hospital services and patients is set, it will be announced in the media, on our website, and by signage in our facilities. The hospital move will take place overnight!



The children's book *The Secret of Saying Thanks* ends with this thought. "We don't give thanks because we're happy. We are happy because we give thanks."

November is the perfect month to focus on giving thanks. As your child thinks about the reasons he is thankful, have him put his thoughts in writing. Here's how.

- 1. Brainstorm with your child. Ask him to name one thing he is thankful for. Your child might say, "I am thankful for our dog."
- 2. Have your child write that statement at the top of a piece of paper. Underneath it, he should write down all of the reasons he is thankful for his dog. For example, he may love the fact that the dog sleeps on his bed. He may like the dog's curly tail. He may love to take the dog on walks.
- 3. Have your child draw a picture at the bottom of the page.

During the month, repeat this activity with everyone in the family. Post these illustrated stories for the whole family to read.


